



## Terms and Conditions of the Recycling Program

1. The Samsung recycling program (the “**Recycling Program**”) is available to customers (“**Customer(s)**”) in the United Arab Emirates, Kuwait, Qatar and Oman.
2. Customer shall be able to participate in the **Recycling Program** by completing the recycling form from: <https://mena.samsung.com/CampaignFeedback/SamsungCampaign?CAMPID=1116&LANGID=1&COUNTRYID=7> and Customer Service Representative inputs the OTP (code).
3. In order to participate in the Recycling Program, the Customer must present his/her ID issued by UAE/KW/OM/QA at the Samsung authorized service center and complete the **Recycling Program Request Form**.
4. The Customer must be at the majority age under the applicable laws of the UAE/KW/OM/QA; and have legal capacity to enter into these Terms and Conditions.
5. The Customer must include the list of the device/devices (the “**Device(s)**”) submitted for the Recycling Program along with the following details; brand, model number, IMEI number or serial number.
6. The customer upon his/her participation in the Recycling Program shall get an instant gift voucher (the “**Voucher**”) that can be redeemed on Samsung E-store (“**Samsung.com**”). The value of the Voucher will be amounting from up to (AED 300/25 KWD/ 31 OMR) for Customers purchasing the Galaxy Products from Samsung E-store (“**Samsung.com**”) as per the below table.   - *\*Customers in Qatar will be able to redeem the voucher from Samsung Authorized distributors the same service centers that deploy the recycling boxes: Qatar Mobile, Ghasham International RP Tech, and Dohatna Innovative Distribution.*

8. Customer shall remove any SIM card or memory cards including personal data from the Device(s) subject to the Recycling Program.

- 9.** Samsung will submit the Device(s) for recycling through the approved recycling company and neither the Device(s) nor any spare parts will be reused again.
- 10.** Samsung and its partner(s) shall not accept liability for loss of any content, data or any other information contained in the Device.
- 11.** Customer is aware of the loss of all data content on the Device(s) including but not limited to contact numbers stored and pictures.
- 12.** Samsung shall be entitled at its sole discretion and subject to any applicable law, to terminate or to modify these Terms and Conditions at any time.
- 13.** Samsung shall not be liable to the Customer for any loss and/or damages of any kind suffered in connection with the Recycling Program.
- 14.** By participating in this Recycling Program, the Customer accepts that any dispute of whatever nature which is directly or indirectly related to these Terms and Conditions, will be subject to, governed and construed by the laws and regulations of the United Arab Emirates/ Kuwait/ Oman/ Qatar and such disputes shall be resolved by the competent courts in the United Arab Emirates/ Kuwait/ Oman/ Qatar.
